- Facilitating easy discovery and retrieval of information for legal, regulatory, and other business purposes

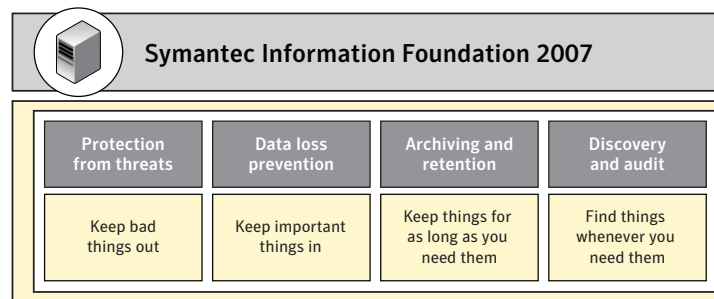
